

## RECENT HIGHLIGHTS

- On 22 January 2019, GlaxoSmithKline plc ("GSK") announced the closing of its acquisition of TESARO Inc ("TESARO"). Because of this transaction, TESARO repaid its \$500.0 million senior loan together with a make whole and prepayment premium. The Company, which had originally invested \$322.0 million in this loan, received a payment of \$369.9 million on 23 January 2019, of which \$322.0 million is return of principal, \$2.2 million in accrued interest, \$36.0 million in make-whole amount and \$9.7 million in prepayment premium. The Company realized an IRR of 28.8% on the combined tranches.
- On 31 January 2019, the Company received its final payment of \$7.6 million from BioPharma III in the form of scheduled distributions to its limited partners. As a result, this investment realized a 13.6 per cent.
