JUNE 2023 HIGHLIGHTS

Overview

- BioPharma Credit PLC (the "Company") is a closed-ended investment trust established to invest in debt secured by approved life science products. The Company's objective is to generate long-term shareholder returns, predominantly in the form of sustainable income distributions from exposure to the life sciences industry. The Company targets an annual dividend of 7 cents per share and net total return on NAV of 8% to 9% per annum in the medium term.
- Pharmakon Advisors, LP, (the "Investment Manager"), seeks to build a diversified portfolio with downside protection, high visibility and stability of cash flows.

NAV¹

The % total return for June 2023 was 1.14% (includes a starting NAV on 30 May 2023 of \$1.01), which takes the % total return to +6.01% over the 6-month period from December 2022 to June 2023, and +14.04% over the 12-month period from July 2022 to June 2023.²

Portfolio Activity

- At 30 June 2023, the Company's invested portfolio had an aggregate valuation of \$1,178 million across 13 debt investments and \$1 million in equities and warrants. The weighted average loan life is 4.0 years. Overall, the portfolio is 92% invested in senior secured loans and 8% in purchased payments. Of the \$1,088 million in senior secured loans, 98% is invested in floating rate loans and 2% is invested in fixed rate loans. The portfolio has no direct exposure to Russia or Ukraine.
- At 30 June 2023, the Company had \$154 million in cash and \$67 million available to draw through its JPM revolving credit facility.³
- During the second quarter, the Company made three new investments, ImmunoGen, BioCryst and Reata. The Company funded the first Evolus Tranche B installment of \$13 million on 31 May 2023. Total capital deployed for this period was \$208 million.
- On 10 July 2023, the Company funded Tranche B of the Reata investment for \$25 million.
- On 20 July 2023, the Company and BioPharma Credit Investments V (Master) LP entered into a ninth amendment and waiver with LumiraDx to among other matters, (i) extend the time that LumiraDx has to comply with certain minimum net sales and minimum liquidity covenants until 1 September 2023, (ii) provide LumiraDx additional funding in two tranches for up to US\$31 million during the waiver period, (iii) commit LumiraDx to engage advisors to conduct a strategic review of the business and advise on available options, and (iv) provide the lenders with two board observer seats.






Portfolio by remaining years⁷
